#### **Fitting Process:**

- Independent Fitting: Customers can conduct the fitting process independently using the Testa Caliper, accompanied by our detailed measuring instructions available on our website.
- Professional OT Evaluation: For complex fitting needs, Testa-Seat recommends undergoing a
  professional Occupational Therapist (OT) Evaluation. This service assists in precise measurements and
  determining the correct positioning, ensuring the product is optimally tailored to the user's body
  structure and specific requirements.

**Responsibility and Acknowledgement -** If a client opts to proceed with self-fitting without the guidance of a seating expert, they must acknowledge and accept full responsibility for the fit and any subsequent implications related to the seating arrangement.

**Assistance Options -** Testa's team offers tele-assistance for measurements. This service can be particularly helpful when using our body measurement caliper, which is available for purchase on our website.

**Price Quotation:** After the fitting, a quotation will be sent according to the dimensions and accessories defined during the appointment.

**Approval of Quotation and Payment:** After the approval of the price quotation and payment, we immediately begin manufacturing to ensure you receive the product as soon as possible. Also, to ensure proper use and to maintain the user's health, upon signing the price quotation, the client declares that they have read the User Guide, the warranty, and the purchase terms and conditions, which are an integral part of the contract, and they accept all these terms.

**Payment Terms:** Payment can be made via bank transfer, check, Zelle or any other method agreed upon by both parties.

**Delivery Time:** The product is specially manufactured for you and will be delivered within 25 business days from the client's approval of the transaction. Holidays, intermediate days of festivals, holiday eves, Fridays, and Saturdays are not counted in the business days. # **Warranty Coverage**

Testa Company (hereinafter: "the Company") is committed to manufacturing products of the highest quality and suitability for their intended use. This warranty covers the proper operation of the product under normal usage conditions for a period of one year from the date of purchase. The specific conditions of normal use are detailed in Annex 1 of this document.

# **Service and Repairs:**

- Home service, when offered, is a paid service available within delivery areas as determined by the Company from time to time.
- The warranty is based on product usage of up to 10 hours per day.
- The Company, at its sole discretion, will repair or replace, free of charge, any part found to be defective, provided that the product has been used and operated correctly.
- Customers are responsible for bringing the product to the Company's customer service location at their own expense for service under this warranty.
- This warranty is valid only with an original purchase invoice.

## **Warranty Limitations:**

- Repairs under this warranty do not extend the warranty period.
- The warranty does not cover damage resulting from breakage, accidents, burglary, fire, force majeure, malicious intent, negligence (including undue pressure on the product, excessive exposure to the sun, or extreme temperatures), improper use, disregard of instructions, careless handling, or use of inappropriate accessories.
- The warranty is void if any treatment, modification, or repair of the equipment is carried out by an unauthorized person or a technician not certified by the Company.
- The warranty does not cover injuries resulting from incorrect fitting of our custom-made seating systems, which are produced according to the clinical team's instructions.

#### **Additional Provisions:**

- The warranty is subject to the product being used according to the instructions detailed in the User Guide. Abnormal use voids the warranty.
- Signing the warranty form signifies that the purchaser and/or user has carefully read and understood the usage instructions.

#### **Legal Compliance:**

- This warranty is provided in addition to any rights provided by federal law, including the
   Magnuson-Moss Warranty Act, and does not exclude or limit any implied warranties under state law.
